General Body Meetings:

COMMITTEE REPORTS:

HMIS:

- Eric at THN will provide New User Training for the HMIS system April 3rd at the Denton North Library.
- Roshaun is providing assistance to agencies that are behind on their data entry.
- CAN training for the Front Doors will be occurring March 1st and 3rd.
- Near Homeless is defined as “homeless within 14 days”.
- Roshaun will be running a CAN report and then entering the data into HMIS.

Street Outreach:

- No one was identified at Mack Park or behind Kroger at the most recent outing.
- At Emily Fowler Library the group used a table set up out front and offered coffee and sweets. Approximately 5 or 6 people were served and referred for services.
- Jocelyn with Denton Community Clinic does blood pressure checks.
- The Salvation Army of Lewisville is currently expanding and renovating. After that is complete, they will be hosting a Street Outreach table (maybe May or June).

Homeless Prevention/COC/Funding:

- EFSP funds are available but most applicants really fit the ESG program.
- The Permanent Supportive Housing (PSH) program at HSNT will be moved to HOPE effective May 1st.
- There are a total of 20 spots with 16 being filled and 4 being open. They must be HIV positive
- Lena will be moving in with HOPE March 17th.

Point in Time Count Committee:

- At the time of the meeting the number of Surveys obtained was 268. This does not represent the number of individuals, just surveys. Last year's count was 238 homeless individuals."
- The rough draft from THN will be available by February 28th.

Membership:
