NEW BUSINESS :

- List of Services in Denton County
 - Roshaun will work on consolidating a list of services to give to other agencies and churches
- Payday Loan Alternative
 - Small dollar loans based on paycheck given to employees through their employer
 - 18% interest rate, \$20 application fee, 12 month period to pay off loan
 - The payments come out of the paycheck
 - There will be financial education associated with the Payday loan
- Scholarship provided by DCHC?
 - Would pay for a member or outside representative to go to homelessness training/meeting/etc. and bring back valuable information

 - Soon will be sent out after meeting so that they can be reviewed while fresh on everyone's mind

HMIS:

Street Outreach:

- Needs a way to medical attention→ transportation and/or resources
 - will talk with Alice to discuss the specifics

Homeless Prevention/COC/Funding:

- CCA is still waiting on new ESFP funds
 - Will finalize the search for their new President
- Village West Apartments in Lewisville
 - Under new management, rent will increase
- HOPE is still waiting on new ESFP funds
 - Is housing 3 families with DAHC
 - About \$2000-3000 left in ESG funds
- VA vouchers are being provided by CCFW for Tarrant County

Point in Time Count Committee:

- First meeting is 07/17 at HOPE, time TBA

Membership:

- More applications being received at General Body meetings
- Dani is keeping the list updated on the website
- Need more agency “spearheads”
 - Representatives for mental health, substance abuse, etc.
