PREVIOUS MEETING MINUTES – 03/07/2018

Jordan McCarty moved that the minutes from 03/07/2018 be approved. The motion was seconded by Dani Shaw, and the minutes were approved.

REPORTS

- Housing Priority List – CE Report – Katherine Gonzales
 - Katherine reviewed the data gathered from HMIS to date, including the number of single and family households that are in need of assistance in the form of either Diversion, Rapid Re-Housing, or Permanent Supportive Housing.
 - We have been working with front door agencies to update reassessments in the system. This review of assessments has helped clean up the data by removing individuals that have been housed, moved out of the service area or cannot be contacted and therefore placed on the inactive list. The goal is to eventually have the report updated on a bi-weekly or monthly basis.
- Barriers Fund and Current Donations – Courtney Cross
 - Courtney provided an overview of the Barriers Fund and its purpose, which is to promote housing stability and self-sufficiency through family support, landlord outreach and community outreach.
 - We have begun accepting funding requests and issuing assistance.
 - Courtney also provided an updated financial status report. In order to ensure that this fund remains a viable option for agencies, we are working on ways to promote it to the community, including through the UWDC's regular marketing endeavors.

ACTIONS

- PIT Count
 - 2018 Report Overview – Dani Shaw
 - Dani provided an overview of the data gathered from the 2018 PIT Count, including numbers broken down by race, ethnicity and age. The PIT Count serves as a sample of the number of individuals experiencing homelessness in Denton County, which is more fully represented by the data gathered from HMIS.
 - 2019 Planning – Katie Chapman
 - The 2019 PIT Count will be held on January 24, 2019.
 - Katie provided an overview of the various subcommittees for the 2019 PIT Count. A poll will be sent out regarding June meeting dates.

ADVOCACY

- Together Lewisville Presentation – Ashleigh Freyan
 - Ashleigh discussed the various components of the Together Lewisville Coalition, which brings together nonprofits, faith-based ministries, key stakeholder agencies and businesses with an interest in making Lewisville a better place.
 - The primary aim of the TLC is to create connections, sync efforts, and expand the reach of the local community support network in order to increase efficiency, boost community good-will, unify the community in resolving social issues and enhance community resilience.
 - An effort of the TLC is the development of a monthly “One-Stop Shop” for social services. It will allow agencies to come together in one place so that individuals can have their various needs met at one time.

NEW BUSINESS

- Giving Hope, in partnership with Our Daily Bread, is working on a PSH screening day this month, which will assist individuals with HMIS assessments and reassessments. HIV screening will also be available in order to help identify individuals who are eligible for support. Volunteers are needed to help with assessments.
